As previous mentioned, Nordic Ranches Community Water & Sewer District (NRCD) does not own or manage the current water system in Nordic Ranches, Etna, Wyoming. It continues to be a privately held Limited Liability Corporation. As such we do not currently have any expected Tax Levies or charges to the residents of Nordic Ranches. Our beginning bank account balance on July 1, 2023 was \$286.98. Ending bank account balance as of June 30, 2024 is \$128.73. Expenses this year were for our annual Post Office Box rental fee of \$64.00, annual bonding insurance fee of \$100.00, and cost of the newspaper Public Notice announcement for the budget meeting July 2023 of \$14.25. Also, recurring website maintenance of \$150.00. Donations anticipated to cover any budget shortfall.
